GROUP TERM LIFE INSURANCE PROVIDES STABILITY FOR FAMILIES

The last thing you want your family concerned about, at a time when they have so much on their minds, is where they will turn for financial stability. Group Term Life Insurance is a beneficial way to help make sure they are provided for.

WHO IS ELIGIBLE?

All alumni and their spouses under age 60 may apply. In addition, unmarried, dependent children 14 days to 23 years are eligible for \$10,000 of coverage. The premium to cover all children is \$24 per year.

A dependent who is a member is eligible for either member or dependent coverage, but not both. If both member and spouse are covered as members, neither may insure the other as spouse and only one may insure any eligible children.

The coverage is not available to residents of AR, CT, FL, IL, ME, MD, MT, NH, NM, NY, OH, OR, SC, TX, UT, WA and WY.

COVERAGE AMOUNTS

Choose the amount of Group Term Life Insurance you need to help protect you and your family.

Alumni—\$10,000 to \$600,000 in \$10,000 multiples.

Spouse—\$10,000 to \$600,000 in \$10,000 multiples.

The total amount of coverage for an individual insured under this policy issued by New York Life Insurance Company to the Group Insurance Trust for Members of the FSUAA may not exceed \$1,000,000.

The total amount of coverage for an individual may have under all group life insurance underwritten by New York Life Insurance Company may not exceed \$2,000,000.

FEATURES

VALUABLE BENEFIT...

for the same specially negotiated premium

The Living Benefit or "accelerated death benefit" is designed to provide members with the option to have a portion of a terminally ill insured's life insurance benefit paid while he/she is still alive.

The money received under this feature can be used however you see fit. For example, it can help pay medical bills and other outstanding debts and financial obligations...it can help you keep your savings and assets intact...it can help you maintain your quality of living.

To qualify for this benefit, a person must be insured under this policy, under age 70 and diagnosed as having a life expectancy of 24 months or less. Proof of terminal illness will consist of a statement from a doctor and any other medical information New York Life Insurance Company believes necessary to confirm the person's status.

You can request payment equal to 60% of a qualified terminally ill person's in force coverage. The amount payable after the insured's death will be reduced by this payment. (Premium contributions will not be reduced.)

If a scheduled reduction will occur within 12 months of the date the advance payment is approved, the benefit payable will be 60% of the reduced coverage. Note: An insured will be eligible for only one terminal illness benefit during his/her lifetime.

Please note that the receipt of this benefit may affect your eligibility for public assistance programs and may be taxable. You may wish to consult the appropriate social services agency and a qualified tax advisor about how this may affect your personal situation.

Group Conversion Privilege

The policy provides a conversion privilege under certain circumstances of involuntary termination as described in the Certificate of Insurance.

Exclusions

Your FSUAA Group Term Life Insurance provides benefits for death from any cause (except suicide during the first two years your coverage is in force) ... at any time ... in any place throughout the world. There are no wartime or aviation restrictions in the coverage. If a person commits suicide, whether sane or insane, within 2 years from the date his/her insurance takes effect, the Insurance Company's liability will be limited to the premiums paid. If a person's age, sex or any other data is misstated, the correct data will be used to determine if insurance is in force. If insurance is in force, the premium and/or benefits will be adjusted according to the facts.

Your Choice of Beneficiary

You may select any person, persons, trust or other legal entity as your beneficiary. If, at the time of your death, there are no surviving beneficiaries, benefits will be paid to the executor or administrator of your estate, or at the option of New York Life, to the surviving relatives in the following order of survival: spouse; children equally; parents equally; or brothers and sisters equally.

Premiums Are Waived If You're Totally Disabled

If you become totally disabled before age 60, and remain so disabled for 6 months or longer, your insurance will be continued as long as you remain totally disabled – for both you and your insured family members – without additional premium contributions until you reach age 70. The amount continued will be based on the options under which you and your dependents were insured at the time your disability began, subject to the scheduled decreases. You may be asked to provide evidence of your continued total disability from time to time.

EFFECTIVE DATE

You and your dependents will become insured on the date approved by New York Life Insurance Company provided the initial premium contribution has been paid, satisfactory evidence of insurability has been submitted, you and your dependents are actively performing the normal activities of a person in good health of like age [NC residents (a person of like age) on that date]. Any person who is not performing his/her normal daily activities as required will not become insured until the day he/she is performing such activities, provided the person is still eligible.

(Payment of a premium contribution for insurance does not mean there is any coverage in force before the effective date as approved by New York Life Insurance Company.)

When Coverage Ends

Your insurance will continue automatically until the policy anniversary date coinciding with or next following your or your spouse's 75th birthday (23 for children), as long as you pay your premium when due, the Group Policy remains in force and insurance does not end for your class. Dependent's insurance will continue until your insurance ends under the group policy, the group policy is changed to end dependents' life insurance, the person ceases to be a dependent or premium is not paid for the dependent when due. If you die, your dependent children who were insured under the group policy immediately prior to your death may continue to be insured, subject to the terms and conditions of the group policy.

CERTIFICATE OF INSURANCE

This brochure contains only a brief description of some of the principal provisions and features. The complete terms and conditions are set forth in the group policy issued by New York Life Insurance Company to the Association and Society Group Insurance Trust.

When you become insured, you will be sent a Certificate of Insurance summarizing your benefits under the policy.

30-DAY FREE LOOK

If you're not completely satisfied with the terms of your Certificate of Insurance, you may return it, without claim, within 30 days. Your coverage will be invalidated, and you will be sent a full refund, no questions asked!

RENEWAL PAYMENTS AND CLAIMS

Once your application is approved, you will have a 31-day grace period for your payment of renewal premium contribution. When you want to submit a claim, call or write the Administrator for claim forms.

Consider Your Eligibility

Before you request coverage, you must be a member in good standing with FSUAA. Please wait until your application for membership is accepted before initiating insurance request. If you have any questions regarding membership, please contact FSUAA directly.

Get Quicker, Easier Service When You Apply

The information provided when you fill out your Application can make the medical underwriting process quicker and easier. By providing complete and accurate information, you avoid delays that may occur while we wait for missing information to be received and shorten the time needed for underwriting decisions and approvals. We also request that you provide the following information for everyone you are requesting coverage on as well as on any named beneficiary: full name, address, date of birth, Social Security number, and telephone number. Please call 1-888-560-2586 to complete this request. If you prefer enclose a separate piece of paper with this information together with your application.

New York Life Insurance Company relies on your answers and statements. Misstatements or failures to report information on your application may be used as the basis for invalidating your insurance.

The FSUAA Group Term Life Insurance is medically underwritten based on the information provided by you on your Application. It is important that you complete the form truthfully and completely. Your Application is subject to New York Life Insurance Company's approval and more medical information may be requested. A physical exam, EKG, blood test or other medical information may be required. If so we will arrange for an independent professional paramedic to contact you and arrange to perform these simple tests at your convenience. The exam and the blood test will be paid for by the program.

2. Complete the enclosed Application Form. It is extremely important that you answer fully the questions about medical history on this form.
